

Late Toll Nomination Statement



If you have received a CityLink Late Toll invoice and you were not the driver of the vehicle for any of the trips that appear on the invoice you can use this form to either (a) nominate another driver, or (b) state you have sold or disposed of the vehicle and nominate the new owner, or (c) state the vehicle/licence plate was stolen, or (d) reject a nomination. This nomination statement must be completed in full and returned to CityLink by the due date of the invoice for the nomination to proceed. It is important to note, your signature is required in section (e) of this document. If you do not sign this document, your nomination will not be accepted.

Once you have completed this form in full, mail to CityLink Customer Service, Reply Paid 69935, Locked Bag 28, South Melbourne VIC 3205 or fax to 03 8656 8525. A new invoice may be issued to the person or company you have nominated. If you have not nominated all trips that appear on the invoice you must also pay the outstanding balance by the due date.

This nomination process is subject to the Melbourne City Link Act 1995. You should note that it is a criminal offence under section 72AB of the Melbourne City Link Act 1995 to provide false or misleading information in this form.
